**FLAFCC Advanced Education Multidisciplinary Workshop:
I'll See You In Court! But Will I Be Heard? Dynamics of the Courtroom**

4-hour Multidisciplinary Presentation

The Multidisciplinary Workshop will follow a case through the court system. The scenes portrayed are those often experienced in a family law court case. This fictional case will include a hearing in Domestic Violence Court, a Case Management Conference, and hearings on a Motion for Contempt, and Motion to Compel Discovery.

Each courtroom scene will be followed by an analysis, specifically addressing the roles of professionals available for use, rules of procedure, applicable statutes, best practices, and benefits or disadvantages to different courses of action.

Implicit Bias - Don't Allow Your Biases to go Unchecked
Wilhelmina Tribble

This presentation will revisit our biases and the consequences of letting them go unchecked. We have discussed biases for years, but social media, short headlines, lack of time to learn, and our noisy environments can impact our judgment. We need to stop, listen, and think. We need to become more self-aware. And for families and children our responsibility looms large. Family law has a “direct impact on the welfare of the family and society,” per ABA. We should all learn to reflect on the origins of our judgment and decisions and check ourselves before we wreck ourselves...and others.

From this 90 minute presentation, participants will learn the following:

1. Assess your self-awareness in terms of your biases and judgement and how it affects your decisions.
2. Explain how attitude and taking the time to increase your knowledge of certain topics helps to minimize biases, often based in incomplete information.
3. Acquire new skills that will allow you slow down and think about your new knowledge and other competencies before making life altering decisions for families.

Can You Hear Me Now? Communicating With Children And Adolescents In Family Law Case

This presentation for family law professionals will focus on strategies for improving our ability to understand the challenges of comprehending children's communication. Participants will learn about improving the reliability of information obtained from children by conducting developmentally sensitive interviews, using language that children can understand, following a continuum of suggestiveness in questions, and understanding their answers to our questions.

Finding Hope and Healing in Florida's Cutting-Edge Early Childhood Courts
Judge Alicia Latimore and Dr. Mimi Graham

The multigenerational cycle of adversity can be interrupted by using trauma science, changing the tragedy that brings children and families into the courtroom into an opportunity to heal. Like other problem-solving courts, Florida's Early Childhood Courts seek to address the underlying issues that bring families into the judicial system. Core components include trauma informed judges, a coordinated, multidisciplinary team approach, and an evidence-based treatment model. Judge Alicia Latimore and Dr. Mimi Graham will showcase this statewide therapeutic approach to heal trauma and share the hope found in the compelling outcomes in Florida's Early Childhood Courts.

From this 90 minute presentation, participants will be able to:

1. Recognize how the science of trauma and resilience guide key core components of the Early Childhood Court approach.
2. Describe Child Parent Psychotherapy, an evidence based two-generational intervention.
3. List the positive outcomes found in Florida's Early Childhood Courts.

****WORKSHOP A:** Effective self-care and wellness involve the development of practices that will enrich our professional, and personal lives. This workshop will illustrate how to identify the warning signs of burnout, compassion fatigue, and vicarious trauma and will explain how using various self-care techniques can help build resiliency and increase overall wellness. By using activities, videos, and reflection, participants will leave with the tools needed to develop a plan for wellness in the face of burnout, compassion fatigue and vicarious trauma.

1. Recognize the warning signs of vicarious trauma, compassion fatigue, and burnout as it relates to their professional and personal lives.

**Drugs, Alcohol, and Family Court: Science-Informed Responses to
Allegations of Substance Misuse**

Substance use is a common issue in family court litigation. Drawing on the latest research, this workshop will provide attorneys, judges, and mental health professionals with the information necessary to thoughtfully approach litigation involving substance-use dynamics. Topics covered include an overview of addiction, step-up parenting plans, drug and alcohol monitoring, and the various roles practitioners can play in these challenging cases.

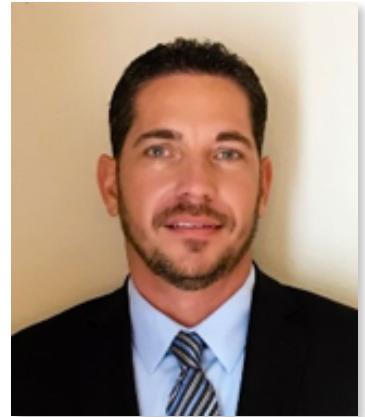
